### REPORT OF THE MEETING OF THE MINISTERS OF TRANSPORT OF THE BSEC MEMBER STATES

Bucharest, 21 October 2015

1. The Meeting of the Ministers of Transport of the BSEC Member States was held in Bucharest, Romania, on 21 October 2015.
2. The Meeting was chaired by H.E. Mr. Iulian MATAACHE, Minister of Transport of Romania.
